Secure upfront payments for major talent, ensuring they commit to key projects and enabling early presales to mitigate budget risks.

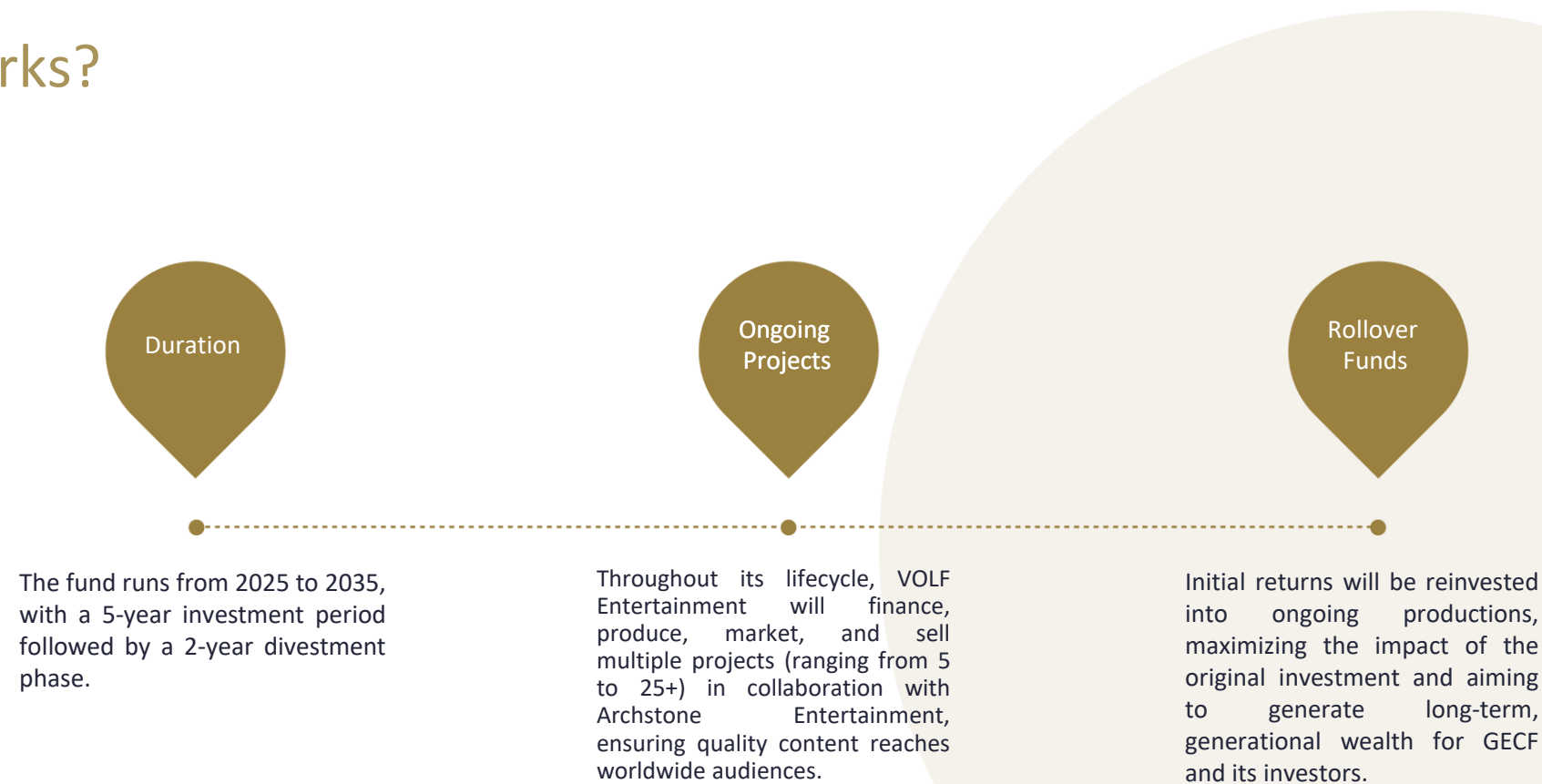
